

NATIONAL GRID DOCTORS AND NURSES SURPRISE AND DELIGHT

OFFICIAL CONTEST RULES

1. Contest Description: The following terms and conditions (the “Official Contest Rules”) shall apply to the National Grid Doctors and Nurses Surprise and Delight (the “Contest”). Any entries received after the Contest Period shall be null and void, and ineligible for the Contest. NEC is not responsible for late, incomplete, or misdirected entries, nor is it obligated to publicly announce the Contest results.

3. To Enter: NO PURCHASE NECESSARY TO ENTER OR WIN THE CONTEST. A PURCHASE WILL NOT INCREASE OR IMPACT YOUR CHANCES OF WINNING. In order to be entered into the Contest, an eligible entrant (“Entrant”) must be nominated by his or her friends, family, peers, and/or colleagues via the Contest entry page available via <https://www.nycblive.com/surprise-and-delight> expressing why the Entrant should be honored with a VIP experience at NYCB Live

All entries, including, without limitation, all Entries, become the exclusive property of NEC. 4. Eligibility: VOID WHERE PROHIBITED. At time of entry, an Entrant must be a doctor, nurse, or other applicable medical professional as determined by NEC who resides in New York, New Jersey, or Connecticut. Contest is void where prohibited or restricted by law. Employees, officers and directors (and their parents, siblings, spouses and children) of (a) NEC; (b) its advertising and promotional agencies; and (c) their respective parents, subsidiaries or affiliates, are not eligible to participate in the Contest.

5. If any of the foregoing documents are not completed, signed, and returned prior to the time specified in the notification message, or if a Winner is deemed by NEC to be ineligible or not to have complied with these Official Contest Rules, then such Winner will be disqualified and an alternate Winner will be selected from the remaining eligible entries, time permitting.

ENTRANTS RELEASE, DISCHARGE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS NASSAU EVENTS CENTER, LLC, AND EACH OF ITS RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES, PARENTS, SUBSIDIARIES, AFFILIATES, AGENTS AND REPRESENTATIVES FROM AND AGAINST ANY LIABILITY FOR ANY DAMAGES, INJURY OR LOSSES, TO ANY PERSON (INCLUDING DEATH), OR PROPERTY, OF ANY KIND RESULTING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY FROM ACCEPTANCE, POSSESSION, MISUSE OR USE OF THE PRIZE OR PARTICIPATION IN ANY CONTEST-RELATED ACTIVITY OR PARTICIPATION IN THE CONTEST.

10. Limitations of Liability: NEC shall not be held responsible for late, misdirected, incomplete, or undeliverable entries. Claims/Choice of Law: (a) Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Contest, but in no event attorneys' fees; and (b) under no circumstances will Entrant be permitted to seek the award of, and Entrant hereby waives all rights to claim, punitive, incidental and consequential damages or any other damages, other than actual out-of-pocket expenses, and hereby waives all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Contest Rules, or the rights and obligations of Entrants and/or NEC in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of New York, without regard for conflicts of law doctrine, and all proceedings shall take place in the State of New York. All Entrants agree to submit to the exclusive jurisdiction of the courts of the State of New York and agree to waive the right to a jury trial with respect to any claim or dispute with regard to any aspect of the Contest or Official Contest Rules.
